Boosting the foundation of the society, the success stories of the women breaking the glass ceiling were shared, and the participants were acquainted with the various welfare schemes available for women.

National Bank for Agriculture and Rural Development (NABARD) stated that the day calls for the equality of women in the society, where they are often not given rights that they actually deserve. Arvind Purohit, Member, Child Welfare Committee; members of *Panchayat*; and about 80 women actively attended the programme.

Road safety is a state of mind, accident is an absence of mind. Keeping this into consideration, it is essential to stay aware of the safety rules on roads and follow them! Hence, to promote road safety measures in the community, schools and the villagers 'Road Safety Week' was observed from



April 23-30, 2018, with the collaboration of Transport Department, Traffic Police at four places in Chittorgarh and Bhilwara districts. Shakeela Banu and Satish Kumar Meena, Sub Inspectors from Chittorgarh Transport Office encouraged the participants to diligently follow the traffic rules and urged them



to wear helmets and use seat belts while driving Besides, a film based on road safety was also shown to the audience. Around 340 people were immensely benefitted by the event.

Financial Consumer Protection Cluster Workshops

A strong consumer protection regime is the key to ensure that expanded access to financial services benefits consumers, so that they can take well-informed decisions for utilising financial services in the best

possible way. Given this background, seven meetings were held in Chittorgarh and Bhilwara districts under 'Financial Consumer Protection' project. The CHD team stated that women should come forward to acquire financial information, training and education. Considering the fact that women hailing from rural areas are not aware of the banking services and financial institutions, hence, through this endeavour, they could avail banking services. In addition, bank officials explained about social security schemes, insurance, pension, investment, credit linkage and challenges faced by financial consumers. Resource persons from various banks believed that this project will build capacities of rural consumers in terms of financial literacy, by enhancing their awareness, knowledge and skills. They assured that banks will help to achieve the objectives of the project successfully. Out of the total 480 participants, 80 percent comprised women.

Anti-Child Marriage Campaign

Anti-Child Marriage Campaign was initiated with the support from District Administration, Bhilwara, which has the highest percent of child marriage. In many communities of the district, girls are considered as burden, and thus are married in childhood only. In addition, patriarchy, caste system and poor education increase vulnerability of girls. The CHILDLINE project team convinced during the campaign that the girls who are married early tend to drop-out of school and teenage girls have a greater risk of complications during pregnancy and childbirth.

Giving Poorer Consumers, Greater Voice

Under the project 'Giving Poorer Consumers, Greater Voice' school activities in four schools and 12 community meetings were held in *Eral* and *Netawalgarh* villages. The consumers were made aware of eight consumer rights and five duties, particularly on water, energy and indoor pollution, and the need to use safe and sustainable products. Interesting stories and messages using folk music on consumer rights and duties was narrated effectively by the puppeteer. About 920 persons attended the event. Furthermore, 140 water and air samples for observing were collected

by Consumer Education and Research Centre (CERC), Ahmedabad in the two villages. The findings would be shared with the community and stakeholders to raise awareness level regarding the quality and harmful components present in air and water.

Know your Rights as a Consumer

It is said, "If consumers know what their rights are, they will be protected. If they are not then they will be exploited". Realising this fact, 'World Consumer Rights Day' was organised by CUTS CHD on March 20, 2018 to promote digital marketplaces that are more accessible, safer and fairer for consumers. C S Charan, District Supply Officer; Sanjay Bhardwaj, Lead Bank Manager, Bank of Baroda; Sachin Badetiya, District Development Manager, NABARD; Arvind Purohit, Financial Literacy Coordinator from Chittorgarh; consumer activists;



volunteers; members from Farmer Producer Organisations (FPOs); and Self Help Groups (SHGs) attended the event. District Supply Officer elucidated about consumer rights/duties, E-Commerce, redress mechanism, exposing scams/frauds being faced to ensure that digital marketplaces are comparatively fair. Around 85 consumers including 70 women participated in the programme.



Welfare Camp Organised

In a Welfare Camp organised by CHD, members from Disabled People Organisation (DPO) project met Vasundhara Raje, Chief Minister of Rajasthan on April 18, 2018 during her visit at Chittorgarh district. The members of the DPO shared their livelihood activities initiated under the scheme under the Department of Social Justice and Empowerment (DoSJE). The Chief Minister provided 19 assistive devices like motorised tricycles, smart cane and hearing aids to the physically challenged people to enhance their quality of life and uplift their social-economic status for self-independence. The occasion was graced by eminent

guests like Shri Chand Kriplani, Urban Development and Housing Minister; Chanrabhan Singh, Member of Legislative Assembly; Leela Jat, Chairperson, District Council, etc.

Clean India Mission

Keeping into account the saying, "If you have time to lean...you have time to clean", 'Clean India Mission' was held on March 22, 2018 at Government Primary School, Banera in Bhilwara district.
